FOOD COMPLIANCE DECLARATION

ALUMINIUM ROLLS, CONTAINERS AND LIDS FOR ALIMENTARY USE

The rolls, containers and lids supplied from Source Atlantique Inc. are manufactured in aluminium alloys (lubricated for lids/containers), suitable for food packaging.

The product is conforming to the following CE REG:

- Reg. CE 1935/2004 and following amendment
- Reg. CE 2023/2006
- Dir. 92/59 and following amendment
- Reg. 94/62/CE

The technical composition of the above-mentioned alloys falls within the bounds of the European rule:

- EN 602 "Aluminium alloys destined to be in contact with alimentary substances"
- EN 573-3 "Aluminium and aluminium alloys Chemical composition".





The sum of heavy metals, Hg, Cd, Pb, CrVI is guaranteed max 100 ppm in compliance with the European Directive 94/62/EC (art.11) and they are never intentional added.

The oil used for the lids and containers are constituted of non-animal based materials, for use on aluminium which comes into contact with human food stuffs, in compliance with the UE Reg. 1935/2004, without any use of genetically modified organism (OGM), free of any type of Bisphenol, Phthalates, MOSH, MOAH and nanotechnology.

Containers and lids are suitable for alimentary contact according to the following precautions:

- avoid contact with strongly acid and/or strongly salty food (vinegar, lemon juice, etc...);
- over 24 hours it is recommended to store in freezer or refrigerator;
- not to set to direct contact with electric parts and direct flames;
- range of temperature: $-40 \,^{\circ}\text{C} / +350 \,^{\circ}\text{C}$ (in conventional oven)
- to use only in the microwave's ovens, they allow the use of it.
- the tray should not touch the oven walls 2 cm minimum between the walls of the oven and the tray
- do not put only the containers in the oven.
- avoid storing the product in a damp environment

Migration test are not applicable.

This declaration does not exclude the ascertainment of the conformity of the products supplied to the standards / laws in force, as well as the suitability for the purposes for which they are intended.

This declaration is valid from the date shown below and must be replaced if in case of substantial changes in the production of the material that can change certain essential requirements for compliance or when the aforementioned legislative references are modified and updated in order to request a new verification for compliance purposes. The declaration has a maximum period of validity of 24 months.
