100% Organic Beeswax products are Antibacterial, Breathable and Biodegradable.

Intended Use: To carry groceries, Smooth Filtering and Storage of food products

Usage conditions: The above-mentioned beeswax products are suitable for food material. Herbs, half-cut onions, leafy greens, cut fruit, and anything else you want to keep fresh until later. Place item in bag, fold over top and with a pinch of your fingers, your food stays freshly sealed in the bag!
Cool water rinse or wash with a mild soap, tent to dry and your bags are Ready to be used again and again. If unsoiled simply wipe and put away. Soak briefly to remove and food particles stuck on the bottom. Avoid exposure to heat and hot water to keep your bags and Wraps. Once the bags start to lose their sticky property or the beeswax starts to fall off, it is time to replace them. Repurpose for storage of nonfood items, cut into strips and compost or use as fire starters to light a fire at home or while camping.



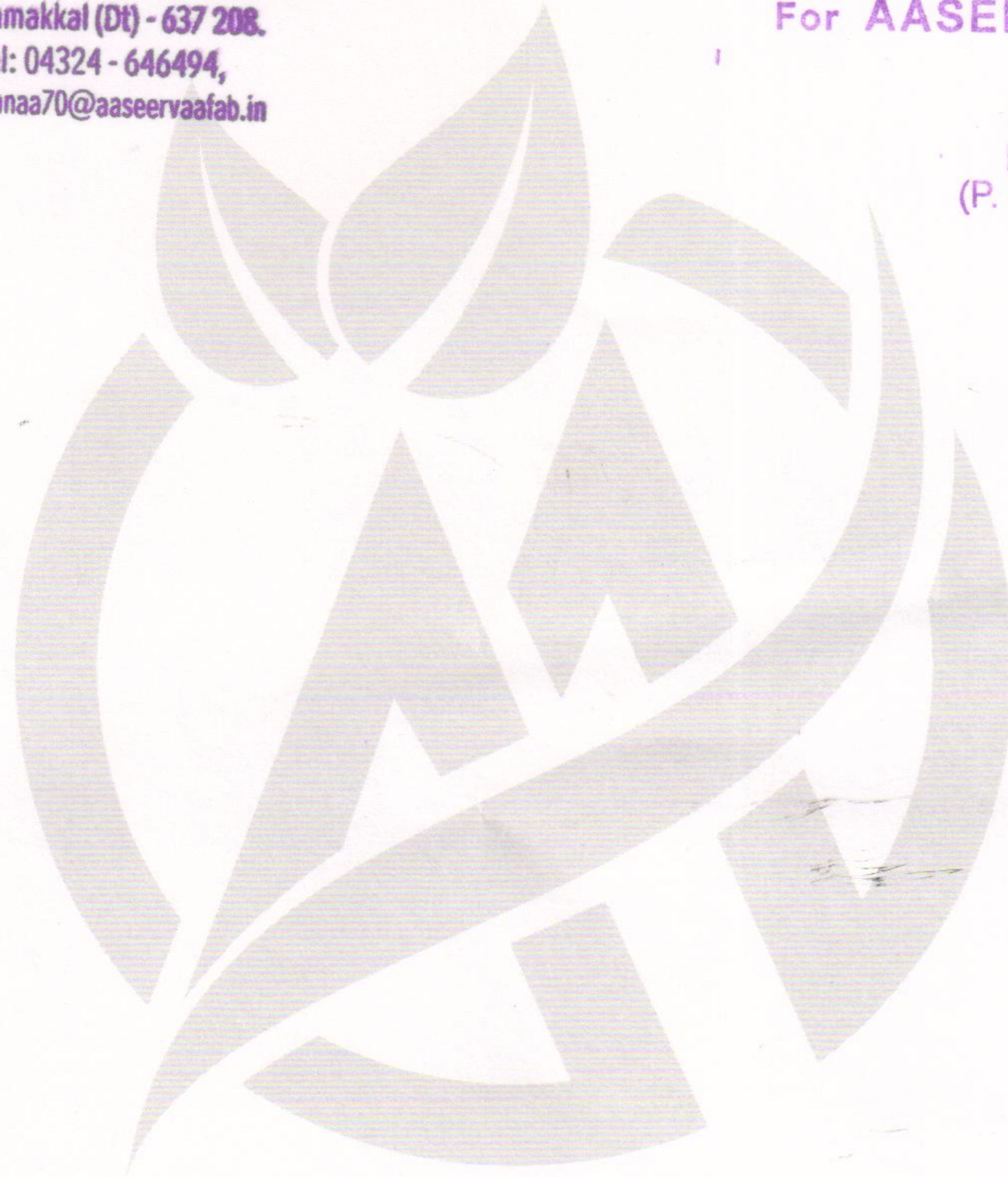
